#### **Old Business:**

Wayne Swanson stated a sign at Nash has a pile of bricks behind it. Tim stated the sign was falling apart and our maintenance crews will haul off the debris because it was a cheaper option. Wayne wanted a clarification about people leaving things at the rental facility will not receive a refund until items are picked up and if Department staff have to remove the items then they lose the deposit.

Jonathan Buck asked about status of raising fees at Village Park. Tim Coley stated the County and Cities are negotiating SDS (Service Delivery Strategy) agreements. The County will address the fees after those agreements are completed. Renters are having incidents at Village Park that really need Park Rangers to monitor like groups running over the rented times, placing trash in dumpster, etc. He would like the County to consider renting the pavilion to one renter per day and raising the rate. Jonathan Buck stated a renter was told he could use a charcoal grill but James Martin explained the rental application clearly states only gas grills are allowed. Village Park is the only pavilion that has a staff person budgeted to assist with rental events and custodial duties. The Department has completed a survey with surrounding County departments for pricing.

The County will address fees, deposits, park rangers, personnel and supplies. It will depend on the funding sources identified by the County after the SDS is completed. Park rangers can work on weekends and verify if a group should receive their refundable deposit. Firms were hired to represent the County and Cities.

### **Department Reports:**

John Dewberry, Jr. requested a revenue report for Locust Grove Event Center rentals.

Wayne Swanson requested a revenue report on 20% of rentals for Nash Farm and wants to know where the funds are. Tim explained that the County's Finance Department handles breaking that down and the report. Tim will get the information from Finance if Commissioner Clemmons does not have it.

### **Public Comments:**

Tyron Williams, Georgia Elite Football, addressed the board regarding a 3 on 3 basketball tournament at South Point Mall last year. The rain stopped the event for a time. He will propose at the next meeting to move the event to the covered Jason T. Harper Event Center at Heritage Park. Georgia Elite will host their 2<sup>nd</sup> Annual Easter Egg Hunt at Avalon Park after their game.
