



These amounts, for which official receipts were issued, were for recording of deeds, mortgages, leases, lawsuit fees, fines and forfeitures, plats and miscellaneous (such as cancellations Xerox copies, etc)

As the cash receipts come into the office, deposits are made into the General Fund of Henry County. A deposit slip is maintained in this office and a copy is delivered to County Commissioners' Office. A detailed monthly report is furnished to them as the source of the funds.

All records are available for inspection in the Office of the Clerk of Superior Court on the first floor of the courthouse. Your visit and inspection is welcomed.

The Clerk of Superior Court now collects Intangible Tax on security deeds filed for record. The County Tax Commissioner previously collected this. We collected the following:


