- Only incidents including the following charges go on “Serious Arraignment” or Must Appear dates (although other charges require a court appearance): DUI, driving with license suspended, misdemeanor marijuana possession, misdemeanor habitual violator, driving with no insurance, hit and run/leaving scene, racing, eluding an officer, fraudulent license, serious injury by vehicle, purchase/possession of alcohol by minor, **and any speeding citation issue for 100 mph or over.**
- If **any** of these charges is written, all citations to that offender should carry the same Serious Arraignment (must appear) court date.
