BUDGET IN BRIEF

The Budget Recap is intended to give a very summarized picture of the Annual Budget, presenting the major Sources of Funds and major Functional Categories of expenditures as are authorized by the Board of Commissioners through appropriation process, thus the title "Appropriations".

SOURCES OF FUNDS

Major Sources of Funds are summarized on the following page. Property Taxes, Sales and Use Taxes and Charges for Services combine to make up 86.08 % of budgetary funding, with Property Taxes making up over half, 51.61%, of the County's resources. Also, Licenses & Permits, Fines & Forfeitures, Grants, Reimbursements, and Misc. Revenues make up the remaining 13.92%.

APPROPRIATIONS

Appropriations are authorizations to fund services. The following page gives a brief summary of the functional areas for which appropriations are made

Public Safety is by far the largest functional use of the County's Resources at 50.85%. At 14.3% of the budget will be General Government, 2.56% Housing/Development, 11.58% Judicial, 3.93% Health & Welfare, 8.16% Public Works, 4.04% Culture & Recreation, and 4.58% Other Uses.
