Question and Answers

1. **Question:** How many cubic yards were ground in the last year?
Answer: 9,800 cubic yards

2. **Question:** Out of the total yards ground in the last year, how many were left onsite and how many were hauled away?
Answer: 0 cubic yards were left at the site and 9,800 cubic yards were hauled away.

3. **Question:** Since this contract is on an as needed basis, is there a certain number of cubic yards that you typically have on the ground before requesting grinding services?
Answer: Yes, usually around 3,300 cubic yards.

4. **Question:** What kind of notice will be given to the contractor when grinding services are needed?
Answer: A two weeks notice.



Request award of contract for waste wood grinding and removal services.

Background/Summary:

Henry County Recycle Center receives a large amount of yard waste (limbs, stumps, and brush) from citizens daily. This accumulated waste wood needs to be ground and removed from the site by the contractor. Having a contract for the grinding and removal allows quick access (without the necessity of bidding each time our yard debris area is full) and guarantees prices will remain firm for a one (1) year period.

This request was bid through the Purchasing Department and posted on the websites of the County, Team Georgia Marketplace, and ACCG/GLGA. Prospective vendors were notified about the posting via the Team Georgia Marketplace and by email with seven (7) vendors responding. Trees & More, Inc. was the overall low bidder for grinding on site and removal of debris. Departmental personnel has reviewed the bids and recommend award to Trees & More, Inc. of Musella, Ga.

Funding for these services is available in the department budget.

Additional Comments / Recommendation:

Departmental personnel recommend award to Trees & More, Inc. as the vendor having submitted the overall lowest and most responsive bid.
